I write to you on behalf of the Estonian Trade Union Confederation in support of Lithuanian Trade Unions in their protest against the adoption of the new social model and reduction of workers' rights.

As you well know the Lithuanian trade unions do not approve of the provisions embedded in the new Labour Code. In any rule of law society the individual as well as collective labour relations strive to provide both security for workers and flexibility to companies to be competitive on the Global market. However, without a balance between the two neither the growth of companies nor skilled and content workforce is possible. Any changes to legislation that affect workers' rights must only be brought about in proper consultation with trade unions.

While modernising labour relations in Lithuania all sides should consult experts from the ILO and the EU to avoid the situation where the newly adopted law goes against Lithuania's international obligations deriving from ratified conventions or EU *acquis*.

We support our colleagues in their demand in stopping the progress of the draft law and engaging in proper democratic processes. Undertaking such huge changes in working life of citizens can only be done with due respect to social dialogue and wider societal consent.

In solidarity with our Lithuanian colleagues we call upon you to stop the progress of the new Labour Code, engage in social dialogue with social partners and to use the expertise and knowledge of experts of the ILO and the EU.

#### Dear President,

The International Trade Union Confederation, which represents 176 million workers in 162 countries and territories and has 328 national affiliates, fully supports the protest rally of its Lithuanian affiliates – the Lithuanian Confederation of Trade Unions, Lithuanian Trade Union "Solidarumas" and Lithuanian Labour Federation - on 10 September 2015.

The trade union rally is organized in protest against the attempts by the Lithuanian Government to curtail employee guarantees, approve excessive liberalization of labour relations and impose restrictions on trade union activities by introducing a new labour code without taking into consideration the opinions of the most representative workers' organisations in the country. Re: Reform of the Lithuanian Labour Code

### Dear Prime Minister,

IndustriAll Europe is alarmed by the draft list of proposals that has been tabled in an effort to reform the Lithuanian Labour Code. A series of the changes in question stand in direct conflict with European law which Lithuania, as a Member State of the European Union, is obliged to uphold. In addition to our legal concerns, we moreover question the ability of the current reform proposals to deliver a work-life balance, employee protection and protection of employment rights, goals that have been set out by you.

The discrimination of trade unions in relation to Works Councils, where the number of trade union Works Council members is strictly limited, is particularly puzzling to us. The inclusion of trade unions in Works Councils is a long-standing, well-established European tradition which is expressed, for instance, through the EU Directive on European Works Councils. Trade union freedom, including the freedom of trade union members to seek election to posts inside and outside the company, is a fundamental right, expressed in the European Social Charter, as well as in ILO convention 87.

We reject any reduction of labour protection and labour rights, in particular the introduction of zero-hour contracts, the opening for a 60-hour work week, as well as drastically reduced notice periods or severance pay. All these measures aim at weakening ordinary Lithuanian workers, create social injustice and breach European Law. Art. 24 of the European Social Charter requires valid reasons and/or compensation for dismissals. An extension of the normal working week on a permanent basis to 60 hours directly contradicts the existing EU Working Time Directive.

Additionally, we have to remark that the entire legislation process that has led to the drafting of the current reform proposals has been marked by the exclusion of trade unions and thus social concerns. Economic growth requires a strong middle class, while your proposals aim to impoverish and deprive them of fundamental rights. The flexibility you seek to establish on the labour market must be balanced by a credible and strong element of security, which at this moment is completely absent from the current draft. Trade union involvement in a legislation process of this kind is, of course, paramount.



We therefore call for the proposed legislation to be withdrawn and fundamentally redesigned with appropriate trade union involvement.



par la présente, nous souhaitons exprimer en tant que CSC de Belgique, organisation syndicale belge avec 1,7 millions de membres, toute notre solidarité avec l'action de protestation commune intitulée "Non à l'esclavage au travail" organisée par les syndicats lituaniens le 10 septembre 2015.

Cette action visait à protester contre la réduction des garanties des travailleurs, l'approbation de la libéralisation excessive des relations professionnelles et l'imposition des restrictions sur les activités syndicales par le nouveau Code du travail.

Les dispositions intégrées dans le nouveau Code du travail que les syndicats lituaniens n'approuvent plus particulièrement pas sont les suivantes ;

- 1. La réduction des salaires (sans rémunération des heures supplémentaires). Suite au nouveau Code du travail, les travailleurs seront obligés de faire des heures supplémentaires.
- 2. La simplification des procédures pour la cessation d'un contrat de travail.
- 3. La possibilité de licencier un travailleur sans raison importante, avec un préavis de 3 jours.
- 4. Des délais plus courts pour les indemnités de départ et les notifications de cessation d'emploi.
- 5. L'introduction de contrats à durée déterminée pour des tâches de nature permanente.
- 6. La révocation du droit à des vacances en raison de l'ancienneté (parcours professionnel).
- 7. La durée maximum du temps de travail hebdomadaire qui passe de 48 à 60 heures.
- La période de travail obligatoire pour l'assurance-retraite légale est augmentée de cinq ans.
- 9. La réduction des garanties pour les travailleurs élevant des enfants.
- 10. La restriction des droits et activités des syndicats.

Your Excellency,

I am writing to you in my capacity as President of LO, The Swedish Trade Union Confederation, and as Deputy President of the International Trade Union Confederation ITUC.

On 10 September, the Lithuanian trade unions organised a joint protest action "No to Slavery at Work" in front of the Seimas and the Government of Lithuania, which was supported by the entire European trade union movement.

In solidarity with the Lithuanian unions, with whom we have close and friendly relations, we are worried about the Lithuanian Government's attempts to curtail employee guarantees, approve excessive liberalisation of labour relations and impose restrictions on trade union activities, which the new Labour Code would entail, in the form of:

- Wage reduction (with no remuneration for overtime provided); pursuant to the new Labour Code, workers will be required to work mandatory overtime.
- Simplified procedure for termination of employment.
- The possibility to dismiss an employee without any substantial reason, with a 3 day termination notice
- Shortened terms of severance packages and job termination notifications.
- Introduction of fixed-term employment contracts for work of permanent nature.
- Revocation of the right to holidays for seniority (work record).

- Maximum weekly working hours increased from 48 to 60 hours.
- The mandatory period of work record for social insurance pension extended by five years.
- Reduction of guarantees for employees raising children.
- Restricted trade union rights and activities.

Therefore we stand in solidarity with the Lithuanian unions in their claims to cease the attempts to undermine employees' rights at work and to ensure continued respect of workers' and trade union rights.

# Lithuanian trade unions demonstration "No to slavery at work"
